1. ***Mangsebung Rural Municipality*** invites sealed bids or electronic bids from eligible bidders for the construction of ***Miklajung Water Supply Project (Chitre Khola Muhan) at Mangsebung 2 and 6*** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 2,66,69,400.00**
 - Minimum Work experience of similar size and nature: ***At least One Lifting Water Supply Project of at least NRs. 71,20,000.00*** (final contract amount).
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .

5. Sealed or electronic bids must be submitted to the office **Mangsebung Rural Municipality** by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egpon or before **12:00** on **03-01-2024**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **03-01-2024 14:00** at the office of **Ivang, Ilam**. Bids must be valid for a period of **90** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **Nrs. 5, 25,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
